- FGP20240022 Apologies for absence** – None
- FGP20240023 Declarations of interest** – Cllr Simpson sits on the D-Day working party.
- FGP20240024 Minutes - To approve and sign the minutes of the F & GP meeting on 10nd January 2024.**

- FGP20240025 Receive an update on actions** - All actions are complete.
- FGP20240026 Propose acceptance of bank reconciliation**

- FGP20240027 Propose acceptance of cashflow.** The RFO advised she has in hand transfers to cover the invoices for the rest of the year and accessible funds.

- FGP20240028 Consider options for new electric tariff for Croft Field** – The RFO has been obtaining rates through Bionic and is still waiting to hear back from TROO. Whilst there is the option to change to a cheaper tariff some concern was expressed about moving to a provider that is not well known.

- FGP20240029 Update on D-Day Expenditure.** The Clerk has submitted a grant application to the Good Exchange for £3332 and is waiting for it to be approved. They have agreed to match fund donations for our expenditure, as all ticketed income will go to charity. The expenditure includes security costs, first responders, portaloos, music and advertising costs.

FGP20240031 Update on obtaining leasehold of Bridge St War Memorial gardens. The Clerk reported that we are no further forward. Our solicitors have asked if we have any evidence to support that the charity was still operating during the period of removal from the register (removal was on 11 November 1998). They have asked when the Town Council was appointed as Trustee of the charity and do we have any documentation to support the appointment.
